



Classifications of Membership for 2017

Membership is for a 12 month period, beginning on April 1st of each year. Dues and food & beverage minimum will be prorated for those members joining midyear. A **minimum one year membership** is required when joining. Membership applications must be approved by the Board of Directors. (Membership charges do not include tax.)

FULL

Full Family Membership offers the use of all Club facilities (golf, swim, dining and clubhouse)

SOCIAL

Full use of club's dining facilities and swimming pool. Limited to three complimentary rounds of golf and can pay for three additional rounds per calendar year. (Cart fees are not included in the complimentary rounds.)

Age 34 and under	WAIVED	\$ 750	(plus \$300 annual food & beverage minimum)
Age 35-44	WAIVED	\$1,065	(plus \$600 annual food & beverage minimum)
Age 45 and over	WAIVED	\$1,380	(plus \$800 annual food & beverage minimum)

BUSINESS EXECUTIVE

A Social Membership is issued in the name of the Business or Firm and said Business may designate up to 6 employees for use. Each designee will have a \$600 annual food and beverage minimum and may play up to six rounds of golf per year; they will be required to pay full green fees when they play golf.

FULL NON-RESIDENT

Full Family Membership offers the use of all Club facilities (golf, swim, dining and clubhouse)

ASSESSMENTS

Fee established to make capital improvements to the club.
New members pay ½ of current members.

Full Golf 45 & over - \$22/month	Social 45 & over - \$15/month
Full Golf 35 to 44 - \$20/month	Social 35 to 44 - \$13/month
Full Golf 34 & under - \$18/month	Social 34 & under - \$11/month
Business Executive - \$22/month	Non Resident - \$20/month

STOCK CERTIFICATE FEE

A Stock Certificate purchase of \$150 applies to all Full Membership classifications. Social Memberships and the Business Executive Memberships are Non-Equity, and therefore do not require a stock certificate purchase. All full members must own stock and be a dues paying member in good standing to be a voting member. If a new member demits or resigns within the first 24-months of joining, they will forfeit repayment of their stock certificate.

- **Though Union Country Club offers monthly billing for the convenience of its members, UCC dues and assessments are levied and payable on an annual basis. Partial year memberships can be granted on a case-by-case basis, only with the approval of the UCC Board of Directors.**
- Unlimited use of Lockers, Locker Room Facilities, USGA Handicap, Shoeshine Services, Golf Club Storage and the Range Program is included in all Full Golf Memberships.
- All memberships have a required food and beverage spending in a membership year. Those rates are based upon your age group. UCC will track your spending on a monthly basis and the unused portion of the required amount will be billed on March 31st annually.
